- Triple P is a system of programs frequently adopted as a population health approach
- The Triple P Implementation Framework supports effective implementation of Triple P
- Most Triple P initiatives include a number of organisations and sectors within a community, rather than a single practice or organisation

# Fidelity, adaption and scaling up



- To achieve the most beneficial effects:
  - Triple P must be provided with fidelity (practice fidelity)
  - Triple P should be available at multiple levels of the system in multiple delivery methods (flexibility)
  - Triple P should be readily accessible to parents at the right level at the right time (minimal sufficiency)

# Why do we need a Community Implementation System?



Scaling up a program, while maintaining fidelity, requires a dynamic approach with strong leadership and the capacity to adapt the implementation processes in response to community context.

### Core principles for a Community Implementation System

- Self-regulation the system is able to selfsustain once full implementation has been achieved
- Minimal Sufficiency the processes and implementation activities are context specific and recognise the existing capacity
- Community Ownership the leadership and community achieves and sustains a sense of

#### Core elements of a Community Implementation System

- Buy-in and meaningful involvement at all levels
- A commonly understood and replicable process based on implementation science
- Clear and explicit roles and responsibilities
- Ongoing communication and influence between levels of the system





### Implementation teams

  - Managing and overseeing the essential implementation functions and activities that are identified in the Framework
  - Guiding the overall implementation of the initiative from engagement to sustainable implementation.
